Tips for Group Registration

1. If you are registering a group of 10 or more, our new registration system offers several options:
 - You can register everyone and pay for the whole group in a single transaction.
 - You can register everyone and pay for the group in multiple transactions. When you go to pay, simply click the checkboxes next to the people you want to include in the transaction. You can repeat this process as needed.
 - You can register part of your group and pay for them in a single transaction. You can repeat this process as needed.
2. If you need to step away before submitting payment, don't worry! The system will remember your entries, so you can log back in and pick up where you left off.
3. When registering, the first step is to see if the person has an existing record. If you see a long Member Lookup List, save time by using the search bar to find their name.
