REMINDER: Judge & Volunteer Sign-Up – Deadline Extended to August 15

Sign-up to be a Judge or Volunteer at this year's National Championship! Access the <u>Judge & Volunteer Sign-Up Sheet</u>.

- 1. Review the available Judge & Volunteer roles and sign up for the one that interests you by August 15.
- 2. IFDA will follow up with you by **August 20** to confirm your Judge/Volunteer role and provide exclusive access to discounted registration.

Each registrant will receive a confirmation letter that includes a link to book housing. The housing link is exclusive to registered attendees and should not be shared. Reservations made without confirmed event registration will be canceled. The deadline for registration and housing is **September 22**.

NEW: Warehouse Competitor Waiver

When checking in at the event, warehouse competitors will need to complete the <u>Warehouse Criteria Waiver</u> confirming their qualifications and eligibility. Competitors can review the form in advance of the competition. Forms will be provided and completed on-site at registration.

FAQ: Warehouse Competitor Preparation

Question: How do warehouse competitors prepare for The IFDA National Championship?

Answer: The OSHA regulation that governs Powered Industrial Trucks is 29 CFR 1910.178. This document is available to you for free at http://www.OSHA.gov. In addition to this reference, we recommend you also focus on your company's internal forklift training & certification program materials. These programs are designed to meet the OSHA requirements and are focused and user friendly. These materials are likely available with the assistance of your supervisor.

FAQ: Travel Plans

Question: What time should I arrive?

Answer: All Competitors and Judges are expected to arrive by 12:00 PM on Thursday, October 23 to allow enough time to check-in, pick up registration materials and arrive to the Orientations and Exams on time. Need more details? The National Championship schedule is available on the website.
